This contract sets out the complete agreement between the outfitter and the client based upon all communications between the parties, and reflects the final agreement concerning the services to be performed and goods provided as well as respective rights and duties. This contract and articles do not in any way guarantee the client a kill or a successful hunt.

### ARTICLES

The outfitter will conduct the hunt in a professional manner and the client will conduct himself as a sportsman according to the following:

1. The outfitter will provide: a properly maintained cabin with sleeping, cooking, dining, shower and toilet facilities; access to hunting licenses; hunt transportation to and from the field.
2. The outfitter will use the best guides and equipment readily available. The outfitter does not guarantee to be personally present.
3. The client will provide their own food, snacks and drinks. The client will prepare all their own meals.
4. Trophies and meat will be handled to these specifications: Bears will be skinned and meat will be removed from the carcass; any further meat processing will be at the clients' discretion. Wolves will be skinned, hides will be frozen. Processing of deer will be performed by client, unless prior arrangements arranged. For all game, the outfitter will provide area to skin and process and freeze the meat. There are freezers on premises to put hides and meat in for cooling. All taxidermy requirements will be at client's discretion.
5. The client will provide their own meat storage materials (e.g., zip-lock backs; freezer paper and tape).
6. Hunting may be completed on foot, or on stand; whichever method is deemed appropriate by the outfitter.
7. The outfitter will be responsible for the conduct of all employees in camp and in the field.
8. The outfitter will be the final authority in the operation of the camp and the hunt, and at no time will his authority be challenged. Any questions and/or complaints will be taken up directly with the outfitter or his guide in charge if the outfitter is not present.
9. The outfitter will not be responsible for accidents occurring in the camp or in the field.
10. The outfitter can, at his discretion, change dates or reduce the number of days specified in the contract for any of the following reasons: (a) weather or unpredictable and unusual circumstances which may affect the safety and/or well-being of the client, (b) all clients have filled their license, or (c) Division of Wildlife season changes or modifications.
11. The outfitter may, at his discretion, change hunting areas and methods to best increase your opportunity to make your hunt successful. Hunting areas are of varying conditions and all suited for particular game.
12. The client will strictly adhere to all Division of Wildlife regulations (<http://www.gov.mb.ca/conservation/wildlife/hunting/>), along with any additional hunting, camp and Moose Lake Provincial Park rules as verbally specified by the outfitter.
13. The client will closely observe the advice and recommendations of his guide and will not go out on his own unless approved by his guide or outfitter.
14. The client will practice proper firearm safety at all times.
15. The client, if unable to abide by these rules set forth by the outfitter, may be asked to leave camp immediately. No money will be refunded.
